



## **MnTC Programing Initiatives**

MnTC provides comprehensive and holistic treatment to those suffering from substance use disorders. We offer in-depth services to a diverse clientele with a history of chronic addiction. A multidisciplinary staff of mental health professionals, drug & alcohol counselors, coaches, chaplains and community advocates deliver person-centered, culturally responsive and trauma- informed care. The clients at MnTC are treated with a dignity and care, empowering them to live a restored life.

We have expanded our services to 12 locations within the state of Minnesota and in 2021 MnTC served 3,475 individual clients through short term and long term programming, outpatient services and telehealth services.





## **Brainerd Expansion – Women's Facility**

The MnTC Board has approved the formation a women's program in Brainerd. Forty acres of land which include three buildings will serve as the new Women's Program Center.

There is a significant lack of residential women's treatment centers in central Minnesota.

Women suffering from addiction face many obstacles in receiving the help they need. Rural areas like Brainerd and surrounding communities bring about the challenge of transportation, limited treatment options and needed childcare for mothers. Women are often left trying to care for the needs of their children while neglecting their own mental, spiritual and physical needs. This year MnTC will be adding this women's campus, adjacent to the existing men's campus, to serve the women in this region.



#### **Specialized Programming**

Part of our person-centered approach has involved creating specialized program tracks to fit the unique needs and life experiences of our clients. These programs include:

- Legal Aid Clinic The MnTC Legal Clinic was created to assist our clients who have outstanding legal issues related to their addiction. Our clients are able to obtain direct legal representation through the Clinic on a pro-bono basis. Clients have issues that involve criminal, family, and child protection matters. Other areas that often need to be addressed are employment law, veterans' issues, driver's license reinstatement and bankruptcy. These services are life changing for an individual to have a fresh start to life after treatment.
- Veteran's Outreach Program Many Veterans have coinciding mental health issues along
  with a substance use disorder. It is common for individuals who have served in the military to
  suffer from PTSD and consequently, addiction. These issues can be unique to the active duty
  experience. As part of our strategic Veteran Programming, MnTC meets the unique needs
  of veteran's addiction in providing targeted outreach, counseling and transitional services
  specific to veterans' needs.
- CPS (Child Protective Services) Program, Rochester There exist high demand for family restorative programming in the Rochester area. With the success of the Minneapolis program, our Rochester campus is piloting a track for parenting moms with children. In partnership with the state of Minnesota's Child Protective Services (CPS), MnTC's CPS Program assists parenting mothers regain custody of their children through comprehensive and evidence-based programming for them and their families.
